## Abstract of Local Law Intro. No. 4-1-2024 To be Submitted to Electors for Approval

Abstract of Local Law Intro. No. 4-1-2024, entitled "A LOCAL LAW, amending Local Law 1-1959, constituting the Erie County Charter, as amended, in relation to the repeal and replacement of Section 2516 for the purpose of authorizing the Erie County Legislature, when required by the state, to extend the County's current imposition of the state authorized 1% and 0.75% sales and compensating use tax by majority vote".

The purpose and effect of this Local Law is to require that the county legislature impose the state authorized 1% and 0.75% sales and compensating use tax by simple majority vote instead of the presently required affirmative vote of two-thirds.

## Proposition of Local Law Intro. No. 4-1-2024

#### To be Submitted to Electors for Approval

Proposition of Local Law Intro. No. 4-1-2024, entitled "A LOCAL LAW, amending Local Law 1-1959, constituting the Eric County Charter, as amended, in relation to the repeal and replacement of Section 2516 for the purpose of authorizing the Eric County Legislature, when required by the state, to extend the County's current imposition of the state authorized 1% and 0.75% sales and compensating use tax by majority vote".

### Alters certain voting requirements in the Erie County Charter.

Requires that the county legislature impose the state authorized 1% and 0.75% sales and compensating use tax by simple majority vote instead of the presently required affirmative vote of two-thirds.

A "YES" vote adds this simple majority vote requirement to the Erie County Charter.

A "NO" vote leaves this simple majority vote requirement out of the Erie County Charter.
